## Combined Elder/Deacon Session

  - Be aware of families around us and their needs; be welcoming, and praying
  - Break out of comfort zones...move around and meet new people

## **Expense Reimbursement Policy**

### 1) Overview

- Ebenezer Bible Fellowship Church (EBFC) recognizes that certain expenses paid by the pastors are part of the ordinary and necessary costs of the ministry. Accordingly, we have established an Expense Reimbursement Policy to cover these costs.
- b. A "Reimbursed Expense" account line item shall be included in the budget for each pastor and shall be in addition to the Pastor's annual salary. The amount of the reimbursed expense line item will be reviewed annually by the PRC during the budgeting process to determine if any adjustments should be made for the following year.
- c. Any unused portion of the expense account will not be paid to the pastors at year-end, but will be unspent budget for the year. Failure to follow this requirement will result in the expense reimbursement amount for the year being included as taxable income.
- Use of EBFC credit card will be in accordance with the "Procurement Credit Card Policy".

### 2) Expense Account Guidelines

- 1. The pastors shall be reimbursed from the reimbursed expense account for his ordinary, necessary and reasonable expenses incurred in the conduct of the ministry for and on behalf of the Church. The following are examples of expenses that would be considered necessary and reasonable.
  - Books, subscriptions and periodicals either hard copy or via electronic medium.
  - Continuing education and seminars These are encouraged and should be charged under conference expense line item. Expense reimbursement can only be used with the approval of the PRC. Travel to and from such conference or continuing education would be covered under "f"
  - Automobile payment for mileage, tolls, parking when using personal vehicle for travel, visitation or other situations as required by the ministry of EBFC. Guidelines for this expense:
    - The mileage rate will be in accordance with the "standard federal mileage rate".
    - ii. Mileage to be included should be mileage related to the event or situation. For example, taking a side trip for personal reasons while travelling would not have that mileage reimbursed.
  - Entertainment required for EBFC business lunches or meals fall into this category. As a rule, these need to be guided by legitimate business purpose. In the submittal and approval of these expenses there needs to be an evaluation by both the pastor and approver as to the legitimacy of the expense. By way of guidelines the following are guidelines to follow:
    - Off-site meals with only pastoral staff included. This should be kept to a minimum and the senior staff member in attendance should pay. Those involved should always ask, "Could the meeting be held on site vs. having an off-site with a meal." High level of frequency of offsite meals could result in these expenses being viewed as an employee benefit vs. a legitimate business expense.
    - Lunches where the entire staff is involved, the senior member of the group should pay ii. for the bill. Approval by the PRC should be provided in advance with a justification for the expenditure is provided and approval given.

- iii. Off-site meals or entertainment should be for the purpose of the pastor to be ministering to the other individual or group in line with the pastor's duties and responsibilities. Relationship to the individual should also be identified.
- e. Travel fares, lodging and meals while on business for EBFC
- f. Other expenses related to the ministry approved in advance by the PRC or the Senior Pastor.
- 2. All expense reimbursement should be given an adequate accounting of each expense item, including but not limited to a statement concerning the expense, an account book diary or other similar record showing the amount, date, place and purpose of the business and associated receipt for expenses over \$25. For expenses less than \$25, documentation as to the purpose of the expense a description of the expense and the associated credit card bill or other detail identifying the expense.
- 3. It is the intention of this policy that reimbursements will be paid after the expense has been incurred vs an advance for a future purchase. It is recognized that expenses for travel would be before the trip, but the expense will have taken place.
- 4. Expense reimbursement should be for EBFC business expenses only and should not be used for personal expenses. In the event personal expenses are included in a particular expense report the amount should be reimbursed by the Pastor at the time of seeking approval for the expense account or as soon as practical.
- 5. Expense account reimbursement should not be used for computer equipment unless pre-approval is obtained from the head of the PRC committee. It is the intention of the budget that computer equipment and accessories should be included within the technology budget for the church and not included within the pastor's expense accounts.

### <u>Letter of hire for worship internship for Alyssa Heric.</u>

Alyssa is majoring in music and Eastern University. She approached me with a request to serve and shadow different worship responsibilities for the summer to fulfill credits needed for her graduation.

14 hours per week for 12 weeks

She will be doing 3 components

- 1) Learning the philosophy behind the worship we do at Ebenezer
- 2) She will be taking responsibility of the tasks associated with the position
- 3) She will be ministering through the music in selecting and incorporating arrangements as well as leading in music.

Wed. night start @ 7:30 by helping with set-up and assisting in the worship practice (2.5 hours)

For one day during the week she will be in the office shadowing Heather and myself to understand the process of selecting and preparing songs as well as the administrative responsibilities associated with the position (4-6 hours per week)

On Sunday she will assist by participating in the Sunday services and ultimately plan and orchestrate her own worship set for the service. (5.5-6 hours per week)

In addition she will be helping with a music outreach opportunity such as Vacation Bible School, Light in the City, or another opportunity. (VBS 20 hours & LITC 20 hours)

She will also be required to read a book *Worship Matters* by Bob Kauflin that we will discuss throughout the summer.

I propose that we pay her \$12 per hour for her time in assisting us in worship music ministry. This is a way to bless her for her commitment to the local church and help with her college expenses.

# Pastor of Discipleship Report, Apr/May 2018

**MERGE Ministry Update: Mar. – Apr.** 

**Update:** 

### **Current Study Series:**

We have continued in our study on Paul's 1<sup>st</sup> recorded letter to the Corinthian Church. Our times have been challenging as we recognize we are not too different than our struggling brothers and sisters at the time of Paul's letter. However, as we have taken an honest look at our own walks with Christ, we have found the joy of our salvation that Paul so strongly desires for the church in Corinth. I have been taking the study slowly in order to draw out the depth of Paul's writing. After a month long break to consider sexual purity, we will likely remain in the letter through the summer.

### **New Study Series:**

We will be taking a month long break to do a topical series on Sexual Purity as a result of Paul's clear admonishment of the sexual sins present in the church. I believe that this is an appropriate time to challenge our youth to a greater understanding of and commitment to sexual purity. Our lesson breakdown is as follows:

Week 1: A study on 1 Cor. 5 (Apr. 17)

Week 2: What is purity of the heart? What is sexual purity? (Apr. 24)

Week 3: Purity is not simply abstinence. (May 8)

Week 4: God honoring sex is an act of worship, but never to be worshiped. (May 15)

Week 5: Sexual mistakes are not beyond redemption. (May 22)

\* I have attached an email letter that I sent home to parents when we announced our intentions to begin this series. The letter was sent about a month before the study in order to provide parents an opportunity to address any potential concerns.



#### **Planet Wisdom:**

We had an opportunity in Mar. to take a group of 25 MS and HS youth as well as 8 leaders to the annual Planet Wisdom event in Washington, DC. This year's theme was the role of the Holy Spirit. Youth were challenged by God's Word, solid doctrinal truth, and a call to put these words into practice in our lives. While the travel was difficult due to poor weather conditions, the Lord was faithful to provide protection and safety for all involved.

I was particularly blessed to engage in a breakout session with the 11 boys who came and was encouraged by their vulnerability as they collectively shared areas in their lives

in which they believed the lies Satan and others placed before them. Each boy shared a specific lie and the rest of the group had the opportunity to speak truth into that lie. It was an amazing testimony to the work that God is doing in the hearts of these young men through the Holy Spirit.

### Student Leadership:

Jenn and I continue to lead G3 Student Leadership at our house every other Sunday night. During these times we have been working through the book, "Gospel Growth". After a brief lesson time and discussion together as a group we break the boys and girls into separate prayer groups and spend time praying for one another. Our challenge is always for individual's prayer requests to be linked to what they were challenged by in the lesson. We have had a few fellowship nights that are continuing to develop relationships not only between the youth but between the youth and our family as well. My sons have begun to ask when their friends are coming over to study with us, which has been a blessing to witness just how much these youth love our kids well.

#### Youth Volunteer Staff:

Jenn continues to host our Youth Leadership Team for dinner every other month where we fellowship, vision cast, process issues, and prepare for the months ahead. These times have not only been beneficial logistically but relationally as well. I've said it many times before but we are so blessed to have such faithful servant leaders who are committed to God's Word, each other, and the youth. We are thankful that these times have helped us prepare in ways that make our ministry much more effective here.

#### Summer's Coming:

As much as I can't believe it, summer is rapidly approaching. We are encouraging our youth to consider serving at EBFC's VBS, Light In the City, and the DR Trip fundraising efforts. We believe that MERGE exists to not only equip our youth with truth but to embrace the truth and live it out in the world around them. These summer service opportunities provide a place to put their faith into action and we are committed to challenging youth to "go" with the hope of the Gospel.

#### Dear Parents:

I continue to be humbled by God's call on my life to minister to your kids and this church. As I have had the opportunity to teach, disciple, and grow together with these youth, I have been greatly encouraged. Our times of fellowship have strengthened relationships and I am thankful for His Spirit as He continues to draw us together in unity.

I wanted to take the opportunity to share about a future study that will be taking place during our Tues. night youth groups. As we have been studying 1 Corinthians over the past months we are approaching I Cor. 5 which addresses the sexual impurity of the Corinthian church. While I am confident God's desire is that we'd teach the entirety of His Word, I am aware that this may be a more sensitive subject due to the ages, experiences, and maturity of our youth. I want you to know that these lessons will be bathed in much prayer, study, and counsel. My intention is that I would use 1 Cor. 5 as the introduction to a longer series on sexual purity.

I wanted to give you a brief look at how I have outlined these lessons and provide an opportunity for you to share any concerns you may have. Ultimately, God has called you to be the primary individuals who provide discipleship to your children. While I am thankful to be another source of that teaching and discipleship, in no way would I desire to usurp your role. I pray that you have been taking time to talk to your children about sexual purity in regard to God's Word. Statistics suggest that the average age of exposure to explicit sexual content is 8. It is crucial that we are a louder voice than the culture and that starts with the Church and our families.

The following is a brief outline of my intended study times with our youth.

Week 1: A study on 1 Cor. 5 (Apr. 17)

Week 2: What is purity of the heart? What is sexual purity? (Apr. 24)

Week 3: Purity is not simply abstinence. (May 8)

Week 4: God honoring sex is an act of worship, but never to be worshiped. (May 15)

Week 5: Sexual mistakes are not beyond redemption. (May 22)

Each one of these studies will be backed with Scripture and handled appropriately in the context of ministry to youth of all ages. My intention is to invite parents to one of our lesson times and then provide a group discussion for parents while the youth participate in their usual growth group times.

I would appreciate your prayer as we address these passages in Scripture as well as their impact on our Christian walk. May you, our youth, and the Church be blessed by these times.
