

Board of Elders Meeting October 10, 2011

Roll Call:

- Hoy, Bickings, Culton, Sommons, VanDoren, Capaldi, Brimer all present.
- Wayne Batten was excused from the meeting.

Devotion - Articles of Faith Review:

Pastor Dick Bickings led the men in a review and discussion of Article 11 on Election.

Prayer:

The men shared in a time of thanksgiving and prayer.

Approval of Minutes:

The men reviewed the minutes from the Board of Elders Meeting held on September 12, 2011. **Motion** was made to approve the minutes, seconded and passed.

Financial Report:

- Andy Brimer, co-Treasurer, reviewed the September Financial Report with the elders. (Attachment #1) **Motion** was made to approve the report as submitted, seconded and passed.
- The men discussed how we could better communicate our finances to the ministry leaders and the congregation. Several options were discussed such as sending reports to ministry leaders throughout the year showing expenses for their ministry as well as sending out a quarterly financial summary to the congregation in the e-Newsletter. This could lead to greater visibility into the church's financial position.
- 2012 budget planning was discussed. Andy & Mike Capaldi, co-Treasurer, will assemble the workbook for preliminary review and feedback at the October 24th joint Deacon/Elder meeting. The budget will need to be approved by the Elder Board at the next Board meeting on November 14th.

Pastoral Reports:

- 1) <u>Interim Senior Pastor</u> (Attachment #2)
 - Pastor Jason Hoy, Interim Senior Pastor, reviewed his monthly report.
 - Jason led a discussion about following up with people and the importance of reaching out to newcomers.
- 2) Youth Pastor (Attachment #3)
 - o Pastor Mark Culton, Youth Pastor, reviewed his monthly report.
 - Several of the Elders commented on the success of the recent prayer walk and it being a very positive event for all. Special thanks to the volunteers who helped make this happen.
- 3) Pastor of Discipleship (Attachment #4)
 - o Pastor Dick Bickings, Discipleship Ministries, reviewed his monthly report.

Discussion Items:

- 1) Senior Pastor Search/Hiring Committee Update:
 - Mike Capaldi, Committee Chair, provided the men with an update on the process to date.
 - Over 170 resumes have been reviewed, and from those, five men were identified to be
 interviewed by telephone or Skype during October. Upon completion, we will prioritize
 the candidates and decide whether or not we would interview any of them again.
 - In order to provide the Board of Elders with insight into our top candidate(s), we will provide information about the candidate to the Board in the event that we invite them back for a second interview.
 - Since Pastor Hoy is a final candidate, he will be interviewed when we get to that step with any other candidates. Pastor Jason and the elders agreed with this approach.
 - As always, the committee asks for your continued prayer during this process. Please pray for wisdom, discernment and the Holy Spirit's working in all of us during this time.
- 2) <u>People Concerns:</u> The elders discussed three matters concerning members of our congregation. In one case, Mark Culton will be following up with an individual.
- 3) By-Laws Revisions:
 - The elders reviewed the final portion of the By-Laws for the church with input from Pastor Bickings on Discipleship.
 - Motion was made to approve the by-laws as submitted, seconded and passed.
 - Mike Capaldi will ask Wayne Batten, who has led this effort, to create a cover memo that summarizes the areas that were updated and/or changed. This and the revised by-laws will be distributed to the congregation for review prior to the Dec 11th Budget Meeting. At that meeting the by-laws can be approved by vote by the congregation.
- 4) <u>Budget Meeting Agenda, December 11, 2011:</u> The elders decided that the December 11th budget meeting should also be a prayer & praise meeting to include the review of the budget and approval.
- 5) <u>Christmas Day Services:</u> The elders agreed to the Deacons' recommendation to host a single service on Sunday morning, December 25th. The reason for the request is to be sensitive to volunteers and staff time on Christmas morning, trying to protect as much time for them to spend with loved ones. Also, the last time Christmas was on a Sunday attendance was only 50% of the normal Sunday morning. Because of this, we feel confident that one service will suffice and minimize people's time away. The service time will be <u>10:00 am on Christmas</u>.
- 6) Joint Deacon/Elder Board Agenda, October 24, 2011:

The elders agreed to the following agenda to be followed during the upcoming joint deacon/elder meeting:

- 1. Preliminary budget review
- 2. Vision discussion
- 3. Security recommendation about locking classrooms
- 4. Property matters
- 7) <u>Vision Discussion:</u> The elders continue to be led to review and enhance the vision for Ebenezer. Knowing that this is an important task, the discussions have been very broad thus far and we continue to pray that God would guide us in this important leadership matter. We also realize that having ample time in the best possible setting will allow us to do this well. We are holding

November 28th for a potential date of spending all of our meeting time on the subject of visioning.

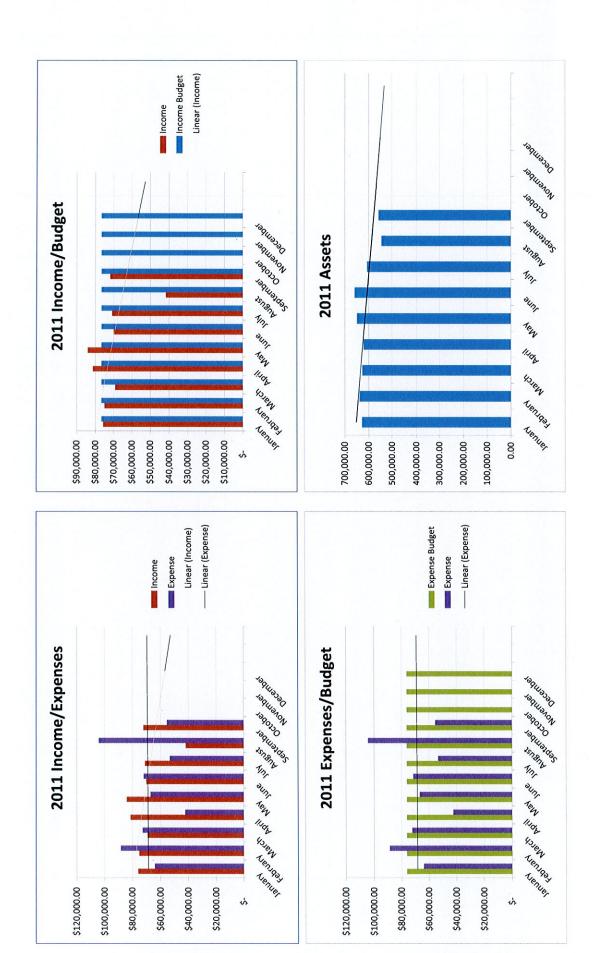
Subject: Financial Report for October 2011

- We praise God for His continued faithfulness to us!
- Giving for September was 94% of the budgeted forecast while the YTD giving is at 93% of the annual forecast.
- Expenses for September were 72% of the budgeted forecast while the YTD expense level is at 90% of the annual forecast.
- We recommend that we remain diligent with current spending and our assessment of any major financial decisions in the coming months.
- Pray as we assemble the proposed 2012 ministry budgets and discuss them keeping in mind the ministry goals and alignment with the vision God has given us here at EBFC.

Ephesians 4:11-14 (ESP)

And he gave the aposites, the prophets, the evangelists, the shepherds and teachers, to equip the saints for the work of ministry, for building up the body of Christ, until we all attain to the unity of the faith and of the knowledge of the Son of God, to mature manhood, to the measure of the stature of the fullness of Christ, so that we may no longer be children, tossed to and fro by the waves and carried about by every wind of doctrine, by human cummng, by craftiness in deceifful schemes.

Here is a classic text that we look to in order that we might effectively disciple our people. But are we discipling like this in our student ministry? I hope so, but I have been convicted lately that we need to focus much more on personal discipleship, starting with evangelism. And so, our focus for our student leadership this year is on personal evangelism. We have also kicked off a 4 week series on sharing our faith.

I believe that our student ministries must be about the business of making disciples. I also believe that the natural tendency for any youth ministry is to drift away from this and towards fun activities (which can actually support discipleship if they take a backseat).

We also want to continue to keep mentoring and small groups an integral part of the discipleship process for our students.

Join with us as we beg God to bring about conversions in our student ministries, and develop deeper disciples who "grow in their knowledge of God, to mature manhood..."

POD (Pastor of Discipleship) Cast – Sep/Oct 2011

As I continue my personal trek through the book of Psalms, I was awestruck this morning by the simple phase,

"The LORD reigns, let the earth rejoice; let the many coastlands be glad!" (Psa 97:1 ESV)

I meditated on that truth for a moment and asked the question, why is the earth rejoicing as a result of the LORD reigning? And more importantly, why should I rejoice because the LORD reigns? I think the answer is in the very next verse...

"...righteousness and justice are the foundation of his throne." (Psa 97:2b ESV)

In other words, we rejoice because the LORD is on His throne and is ruling righteously and justly. Though I may not see the immediate results of this in my day-to-day experience, nonetheless it is our present reality, allowing me to confidently go about the work He has given me to do!

With that in mind, here is a quick summary of some of the ministry opportunities from September/October:

Kids Crossing

- Cross Time Sunday School: Praise the Lord, we continue to thank Him for providing us with an amazing staff of teachers and helpers!
- Early Childhood (2&3 year-olds): The 8:45 and 10:05 classes are going well, with little progress on staffing the 11:15 service, we therefore continue to split the class into 2 year-olds who go to the nursery, and 3 year-olds who go to children's church.
- Children's Church: The class size is still manageable and so far, we have not received any complaints from the teachers about including the 3 year-olds.
- Wednesday Evening Programs: FaithWeaver Friends continues to go well with a greater emphasis on Bible memorization this year in cooperation with the Sunday School classes. Please continue to pray that the lord will bring in the volunteers needed to serve in this important children's ministry.

Student Ministry

Adult Ministry

- Adult Electives: We are currently running well over 100 in the Adult Electives. As a reminder, here are the fall classes offered: Genesis (Rich Mastronardo), Galatians/Ephesians/Philippians (Dick Bickings), and Discipleship Essentials (Joe Maddock).
- Men's Ministry:
 - Bethel Series: Jason Lee and I began teaching the Bethel Series OT on October 5 & 8 respectively. We are very excited and blessed to be apart of this study, and currently have close to 20 participating between the Wednesday night and Saturday morning classes.
 - o BattleZone™: We are currently running two groups that meet early on Saturday mornings.
 - Men's Bible Studies:
 - Saturday mornings from 8:00 AM -- 10:00 AM, The Bethel Series taught by myself.
 - Thursday mornings from 6:15 AM 7:30 AM, Dave VanWinkle continues in his study on the book of *Romans*, they are however finishing soon and the next study is still undetermined.
- Women's Ministry: I have been meeting with Laura Sommons periodically to focus on mentoring and outreach program possibilities. Continue to pray for Laura and her team as they reach out to disciple the women in our church.

Discipleship Support

- **Kinship:** Kinship Groups continue to function well, with a few people who still need to be placed. I am also working on finding a leader for one group that still meets unofficially, but has no leadership. I praise the Lord for the diligence of each group leader.
- Membership Class & Interviews: We will begin a new membership class on October 12.

Other:

- Continue to meet with several individual men biweekly/monthly to counsel and encourage.
 - o Please pray for one man who recently was discharged from the hospital and is now leaving at home with his wife, after 2 years of separation and counseling.
 - Please pray for another man who has been angry with God for over 35 years for an incident that happened 37 years ago, and after 2 years of counseling, he has finally agreed to read the scriptures and take action to turn back towards God.
- Met with a family who is undergoing financial and deep inter-family struggles. Worked with two young couples and other older men to provide the necessary support for this family.
- Preached once
- Had, and will continue to have the privilege of heading up the $1^{1/2}$ $2^{1/2}$ year-olds MOPPETS class every other Thursday for MOPS. It is an honor to work alongside 3 gifted junior leaders
- Continued to work through my TNARS, BS410 NT Theology course as time permits.
